Open-Access Article on Muslim Chaplaincy

Muslim chaplaincy is an emergent field of research that is gaining increasing importance. The authors, Sophie Gilliat-Ray, Hansjörg Schmid, and Mansur Ali, review Englishlanguage publications in this growing area of professional religious work, particularly in Europe and the United States. They focus on three key topics in Muslim Chaplaincy Studies that have emerged from their research: the training and professionalisation of Muslim chaplains, the vocabulary and sources that underpin Muslim chaplaincy and the growing involvement of Muslim women in this field. The article has been published in the Journal of Muslims in Europe. It is the result of a collaboration between SZIG/CSIS and the Centre for the Study of Islam in the UK at Cardiff University, which began in 2023.

Open-Access Article on Imams in Switzerland

In their article «Always an Imam»: Understanding the Occupation of Imam from Theoretical Perspectives on Professions», Noemi Trucco and Asmaa Dehbi examine the activities of imams in Switzerland and highlight the various structural challenges they face in their work. Using theories of professions, the authors explain why imams in Switzerland feel stressed and overburdened. Their findings suggest that the role of the imam can be conceived as a (limited) profession, raising the question: Can the integration of women into this field help strengthen the professional status of imams?

It highlights the central public debates, particularly the impact of the situation in the Middle East on Muslim communities in Switzerland, issues of secularism, legal developments and the activities of the most important Muslim organizations.
